

## **Museum Park Super Neighborhood Council Meeting Minutes**

**SH-288 Expansion:** Raynese Edwards, Blueridge Transportation Group, and Tim Newton, Stantec (engineer) were present to report on the State Highway 288 expansion. The project includes a 10.3-mile stretch from US-59 to the Harris County line at Clear Creek with the addition of toll lanes and interchanges. The MPNA and MPSN had concerns over the removal of trees in the median, increased noise, pollution, and traffic. Interested in any potential for applying the guidelines of the Livable Centers Study.

- This is a TXDoT owned project. BTG is the developer and Almeda-Genoa Constructors heads up the joint venter constructors.
- 610 and Beltway 8 is the start point in October 2016. Mid 2019 is scheduled for completion.
- Segment 6 of the project is close to Museum Park.
- Road expansion will be contained within the current median. Two lanes each direction.
- An open house is scheduled at the Hermann Park Golf Club on September 29, 6:30-8:00 p.m.
- · Limited reforestation planned. Most changes will be in the middle and not on the embankments.
- Southmore bridge will be redone and slightly raised.
- No traffic will be changed at side roads.

- MPSN requested that the overpasses/bridges be modeled after the LCS bridge recommendations. LCS shared with Stantec for consideration.

- Per Julie Farr, temporary lighting installations money is potentially available per TXDoT, but funds would still be needed to operate, maintain, and manage. - Fence art is another potential idea.
- Offline committee to review other ideas.

#### **Livable Center Study Update**

- Almeda not to be proposed for widening. Recommend that a traffic impact analysis will be needed to trigger changes.
- Language added to parking that clarifies that parking will not ward off economically challenged individuals.

• Parking illustration will show existing parking and not proposed at this point.
