- Meeting at South Central with Midtown, Cynthia Alvarado. Concerns about dealers, volume of trash. Midtown has two full time
  people for cleanup. Downtown Mgmt District has considerably more resources, including trucks. Cleanup projected for week of
  Dec 17. Wheeler/Richmond corridor which abuts Museum Park. TXDot not responding. Houston SE helping w/ Third Ward a lot.
- Funding needed to move 'abandoned property' on CoH property, such as sidewalks. Health department required to be present to determine if 'abandoned property' is clean enough to store.

#### Walkable Places and Transit-oriented Development

Discussion about the MPSN draft TOD letter requesting that MPSN be removed from the ordinance, per Committee Chair Bill Baldwin's comments that neighborhoods could opt out at the 9/11/2019 meeting. TOD and Walkable Places are two separate topics combined into one set of ordinances. Large number of issues still unclear and unresolved. Recent slides show less than

ideal of effects of TOD, which does not appear to contribute to a "Walkable Place". Barbara McGuffey moved and Paul Wilson seconded that we send the letter, requesting Museum Park be exempted this coming year; we want to see how the new Community Parking Plan works. Passed unanimously.
