Natalia indicated that today's goals are to get approval on the minutes and review community engagement plan.

Comments were offered to focus the intent of the notes. Items offered include security concerns and maintenance of some of the neighborhood historical homes.

Other discussion: Regard neighborhood as an ecological system. Paul Wilson shared article, *Transforming Urban Water*. Parks Department needs to be included in LCS discussion since esplanades are part of the park system. Decision was made to incorporate an addendum to the minutes, which will include discussion items.

Susan moved to approve SWA minutes from July kick-off meeting, Ernesto seconded. Unanimously approved.
