Minutes were circulated for approval.

Tamara Bell, Super Neighborhood Alliance incoming president: Spoke to city council earlier today regarding sale of public right of way particularly in regard to the abandonment of 1100 Palm Street. She referred Council to former Mayor Bill White's policy to avoid abandonment of public right of way except in extreme circumstances.

Comments & discussion: Application for Abandonment of 1100 Palm is still on hold after Resolution of Opposition submitted to CM Boykins and the Joint Referral Committee. Application for Re-plat of the property appeared on the Planning Commission Agenda for April 14, but after notice to PC of the Resolution of Opposition, it has been delayed for two weeks. Important for stakeholders to speak at Planning Commission.

Paul Wilson presented the master plan for the Covenant Church addition. Church is arranging for offsite parking across Wichita. Construction scheduled to start early 2017.

CM Boykins invited MPSN Council Members to attend annual Crawfish Boil at Little Woodrow's on Brazos, Tuesday, April 19, 5:30 p.m. District D Spring Cleaning is scheduled for Saturday, April 30. Trash containers will be positioned in neighborhoods throughout the district to encourage neighbors to clean the area.

Kathleen O'Reilly, Livable Centers Study Report: Briefly reviewed materials presented at the 2nd Public Meeting, April 5.

1. Your Walking Loop...requested stakeholders to identify their walking path.
2. Walking as Art Toolkit: Different types of way finding.
3. Transportation: Discussion of TXDOT proposal for the suppression of 59. Decking vs. bridges over 59. Is this the configuration that is best for this neighborhood? Bicycle lanes: currently Houston Bike Plan does not account for the depression of 59. Bike plan is based on the current road systems. Ask for every bridge to include two-way bicycle.
4. Parking: Discussion included: Possibility of a parking benefit fund. Need most rational possible parking incentives in place. Paid parking/permit parking throughout? Bus Parking? Automated parking systems? Parking has not been well developed.
5. Gateways. Add one at 59/main exit. Unify the area.
6. Living Lab Tool kit
7. Question regarding placement of Pedestrian Paths on esplanades-is that possible? Esplanades used as gathering spaces.
