HPD Report: Cmdr. Caroleta Johnson and Lt. Shamara Garner of South Central introduced themselves.

Sgt. Christopher Weiche, SE DRT reported:

- Crimes against persons are down 9%
- Burglary of Motor Vehicles (BMV) is up; thieves are looking for guns. Lt. Garner stated that every third car has a gun stored in the car. Aggravated robberies often occur with stolen pistols.
- Town hall meeting recently attended by many Midtown businesses, who are experiencing frequent break-ins. HPD states many of these break-ins are well-organized.
- HPD cautions not to have phones, bags, etc. showing in car, AND to store items in trunk BEFORE parking at destination.
- They stressed to be aware of surroundings.
- They urged putting ID and serial numbers on property.
- Crime Prevention Through Environmental Design (CPTED) is highly encouraged.

President O'Reilly welcomed and thanked Bill Baldwin for his work on the Planning Commission and chairing the Walkable Places Committee.

Q&A, discussions to better understand setbacks, current and proposed. 15-foot setbacks, when is it applicable and when is optional.

Ex: if utility pole is currently on sidewalk, then the public realm will be on private property

Strong feelings among MPSN that residential buffering ordinances are insufficient. Bill reported that Mayor is asking for more residential buffering, including garage sheathing.

Excessively bright lighting is intrusive.

Noise levels are excessive.

Parking, reduced parking requirements remain a very significant concern.

In MP, some confusion about which streets are primary and which are secondary. Location of front door. We respectfully reminded all parties of the Museum Park Livable Center Study, and our strong preference that its philosophy and recommendations be observed.

President re-stated MPSN concerns that these ordinances are not well-understood by MPSN stakeholders, and information on the CoH website is often inaccurate, not up-to-date, and links episodically do not function. Public Comments scheduled for February 20
